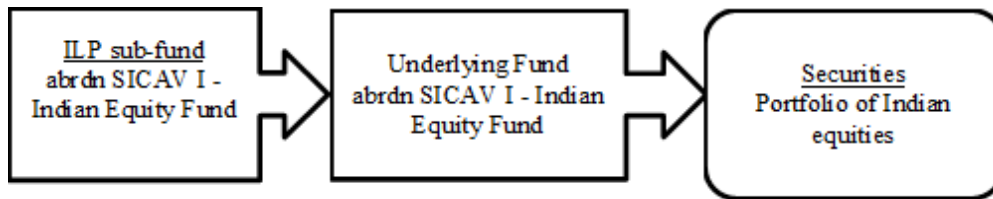

KEY FEATURES OF THE SUB-FUND

WHAT ARE YOU INVESTING IN?

- You are investing in an ILP sub-fund that feeds 100% into the Underlying Fund, a sub-fund of abrnd SICAV I which is an open-ended investment company with a legal status of a société d'investissement à capital variable (a "SICAV") incorporated in Luxembourg and qualifying as a UCITS the law of the Grand Duchy of Luxembourg concerning undertakings for collective investment dated 17 December 2010.

Investment Strategy	
<ul style="list-style-type: none"> The Underlying Fund’s objective is long term total return to be achieved by investing at least 70% of its assets in equities and equity-related securities of companies listed, incorporated or domiciled in India or companies that derive a significant proportion of their revenues or profits from Indian operations or have a significant proportion of their assets there. The Underlying Fund is actively managed. The Underlying Fund aims to outperform the MSCI India Index (USD) benchmark before charges. The benchmark is also used as a reference point for portfolio construction and as a basis for setting risk constraints but does not incorporate any ESG criteria. In order to achieve its objective, the Underlying Fund will take positions whose weightings diverge from the benchmark and may invest in securities which are not included in the benchmark. The investments of the Underlying Fund may deviate significantly from the components of and their respective weightings in the benchmark. Due to the active nature of the management process, the Underlying Fund’s performance profile may deviate significantly from that of the benchmark The Underlying Fund promotes environmental and social characteristics but does not have a sustainable investment objective. Investment in all equity and equity-related securities will adhere to the Underlying Fund’s “Sustainability related disclosures”, which is published at www.aberdeeninvestments.com under “Fund Centre”. Through the application of this approach the Underlying Fund commits to having a minimum of 10% in Sustainable Investments. Furthermore, the Underlying Fund targets a meaningfully lower carbon intensity, than the benchmark. The Underlying Fund Investment Manager’s Overall Sustainability Assessment (OSA) provides an overall view on a company’s sustainability based on scoring of its governance, operations, and products and/or services. To complement this, the Underlying Fund Investment Manager’s equity investment process is utilised, which enables portfolio managers to qualitatively identify ESG risks and opportunities. Companies considered to be exposed to the highest ESG risks will be excluded. Additionally, a set of company exclusions are applied which are related to the UN Global Compact, Controversial Weapons, Tobacco Manufacturing and Thermal Coal. Engagement with external company management teams is used to evaluate the ownership structures, governance and management quality of those companies in order to inform portfolio construction. As part of this, where a company fails the thermal coal exclusion but is identified as having a clear and credible action plan to mitigate the adverse impact associated with these activities, the company will be deemed investable. This is to support their transition to ultimately comply with the thermal coal exclusions. Up to 5% of assets may be invested in such companies Financial derivative instruments, money-market instruments and cash may not adhere to the Underlying Fund’s ESG criteria. The Underlying Fund may utilise financial derivative instruments for hedging and/ or investment purposes, or to manage foreign exchange risks. The use of derivatives for hedging and/or investment purposes is expected to be very limited, mainly in those cases where there are significant inflows into the Underlying Fund so that cash can be invested while the Underlying Fund's investments in equity and equity related securities is maintained. 	<p>Refer to Page 74 and 75 of the Underlying Fund’s Prospectus for further information on the investment strategy of the sub-fund.</p>

Market and Credit Risks	
<p>You may be exposed to Markets Risk Prices of the securities owned by the Underlying Fund may rise or fall in response to changes in economic conditions, political conditions, interest rates, and market sentiment. These may cause the price of units of the Underlying Fund to go up or down.</p>	
Liquidity Risks	
<p>The ILP sub-fund is not listed on the Singapore Exchange and you can redeem only on Business Days through Singapore Life Ltd. In respect of Singapore investors, there is no secondary market for the ILP sub-fund.</p>	
Product-Specific Risks	
<p>You may be exposed to Equity Risk</p> <ul style="list-style-type: none"> The value of the Underlying Fund that invests in equity and equity-related securities. These are sensitive to variations in the stock markets which can be volatile and change substantially in short periods of time. <p>You may be exposed to Concentration Risk</p> <ul style="list-style-type: none"> A concentrated portfolio may be more volatile and less liquid than a more broadly diversified one. The Underlying Fund's investments are concentrated in a particular country or sector. <p>You may be exposed to Emerging Markets Risk</p> <ul style="list-style-type: none"> The Underlying Fund invests in Indian equity and equity-related securities thereby providing exposure to Emerging Markets which tend to be more volatile than mature markets and its value could move sharply up or down. In some circumstances, the underlying investments may become less liquid which may constrain the Underlying Fund's Investment Manager's ability to realise some or all of the portfolio. The registration and settlement arrangements in emerging markets may be less developed than in more mature markets so the operational risks of investing are higher. Political risks and adverse economic circumstances are more likely to arise. Applying ESG and sustainability criteria in the investment process may result in the exclusion of securities within the Underlying Fund's benchmark or universe of potential investments. The interpretation of ESG and sustainability criteria is subjective meaning that the Underlying fund may invest in companies which similar funds do not (and thus perform differently) and which do not align with the personal views of any individual investor. The use of derivatives carries the risk of reduced liquidity, substantial loss and increased volatility in adverse market conditions, such as a failure amongst market participants. The use of derivatives may result in the Underlying fund being leveraged (where market exposure and thus the potential for loss by the Underlying Fund exceeds the amount it has invested) and in these market conditions the effect of leverage will be to magnify losses. <p>You may be exposed to Exchange Rates risk</p> <ul style="list-style-type: none"> The Underlying Fund may invest in securities denominated in a number of different currencies other than the Base Currency in which the Underlying Fund is denominated. VALUATIONS AND EXITING FROM THIS INVESTMENT

HOW OFTEN ARE VALUATIONS AVAILABLE?

All ILP sub-funds will be priced based on the frequency of the fund manager's pricing. The fund prices are updated daily and are available at Singapore Life Ltd.'s website at www.singlife.com.

HOW CAN YOU EXIT FROM THIS INVESTMENT AND WHAT ARE THE RISKS AND COSTS IN DOING SO?

- You can exit the ILP sub-fund by submitting a request for withdrawal or fund switching (i.e. switches) to Singapore Life Ltd.
- If your Policy is newly incepted, you may cancel the Policy by giving us written notice of cancellation provided that such notice of cancellation is received by Singapore Life Ltd. at its Registered Office within the free-look period, which is fourteen (14) days from the date on which you receive the Policy.
- Upon cancellation of the Policy, Singapore Life Ltd. will refund the premiums you paid (without interest) after deducting the expenses incurred in issuing the Policy. The refund will be made after we receive the original Policy for cancellation.
- If there has been a decline in the market value, we will deduct the amount necessary to reflect the change in market value. If there has been an increase in the market value following the date Singapore Life Ltd. accepts your request to cancel the Policy, we will not pay you for such increase or any gain.
- For subsequent withdrawal/surrender or fund switching, transaction requests will need to be received and accepted by Singapore Life Ltd.:
 - (a) before 12 noon (Singapore time) on a Business Day will be processed according to the Unit Prices of the relevant Funds and the exchange rates (if applicable) prevailing on the next appropriate Fund Valuation Date following the day Singapore Life Ltd. has accepted the request.
 - (b) after 12 noon (Singapore time) on a Business Day or on a non-business day will be considered as if received before 12 noon (Singapore time) on the following business day.
- The ILP sub-fund will have a single "dealing" price used for all switches and withdrawals/surrenders. There is no bid/offer spread.
- All ILP sub-funds will be priced based on the frequency of the fund manager's pricing policy. As Units are cancelled using a forward price, the unit price for all switching and withdrawal of units will not be available at the time of receiving your application. This cut-off time stated is correct as at the time of print. Singapore Life Ltd. reserves the right to change the cut-off time by giving you thirty (30) days' prior notice or any such shorter period of notice as Singapore Life Ltd. may agree with the relevant authorities.
- The Withdrawal Amount you will receive as part of a subsequent withdrawal is illustrated as follows:
 - For a partial withdrawal request of 1000 units of an investment-linked fund.
 - Assuming the unit price of the fund is S\$1.50:
The amount payable to the policyholder will be S\$1500, which is calculated as 1000 units x S\$1.50.

APPENDIX: GLOSSARY OF TERMS

Business Day:	refers to any day other than a Saturday, Sunday and gazetted public holiday on which commercial banks are generally open for business in Singapore.
CIS:	Collective Investment Scheme.
ILP sub-fund:	Investment-Linked Policy sub-fund.
Emerging Market:	Any country that is included in the MSCI Emerging Markets Index or composite thereof (or any successor index, if revised), or any country classified by the World Bank as a low to upper middle-income country.
Share:	Any share of any Class of an Underlying Fund.
UCITS:	An Undertaking for Collective Investment in Transferable Securities.
Underlying Fund:	abrnd SICAV I - Indian Equity Fund A Acc USD
